The City of Fort Worth received the above-referenced request for information. We have determined that complying with your request will result in the imposition of a charge that exceeds \$40. Therefore, we are providing you with this cost estimate as required by section 552.2615 of the Texas Government Code. This document is only an **estimate** of the costs the City believes will be incurred in filling your request. If the City determines that the actual charges will exceed this estimate, the City may charge you an additional amount not to exceed 20% of the estimate without issuing an updated cost statement. If, after beginning the work but before providing the copies, the City determines that this cost estimate will be exceeded by 20% or more, the City will issue an updated estimate, and you will have an additional 10 days to make written response to the updated estimate.

The Public Information Act (the "Act") requires you to provide your mailing or email address, for the City to contact you regarding this estimate; it is your choice which method to provide. Please provide your selected method if you have not already done so.

The costs to complete your request are estimated as follows:

Water Department

Approximately: 2.5 hours of personnel time @ \$15 per hour to locate, compile, manipulate data and reproduce responsive information	\$ 37.50
Aviation Department Approximately: .5 hours of personnel time @ \$15 per hour to locate, compile, manipulate data and reproduce responsive information	\$ 7.50
Mayor and Council Approximately: .25 hours of personnel time @ \$15 per hour to locate, compile, manipulate data and reproduce responsive information	\$ 3.75
Overhead charge: 20% of general labor Total Estimated Cost:	\$ 9.75 \$ 58.50
