### Incident Summary

---

While affecting the arrest of Patrick Kelly, subject became combative and refused to comply. Myself and Sgt. Rodriguez informed the subject that he was under arrest for terroristic threats. At such time subject failed to place his hands behind his back. While attempting to control the subject, who was actively resisting, I secured his left arm as he continued to struggle. At one point, while attempting to handcuff the subject, Detective Decandia took control of his left arm and in order to get the subject on the ground, I wrapped my right arm around the subjects face from behind and guided him to the ground. .

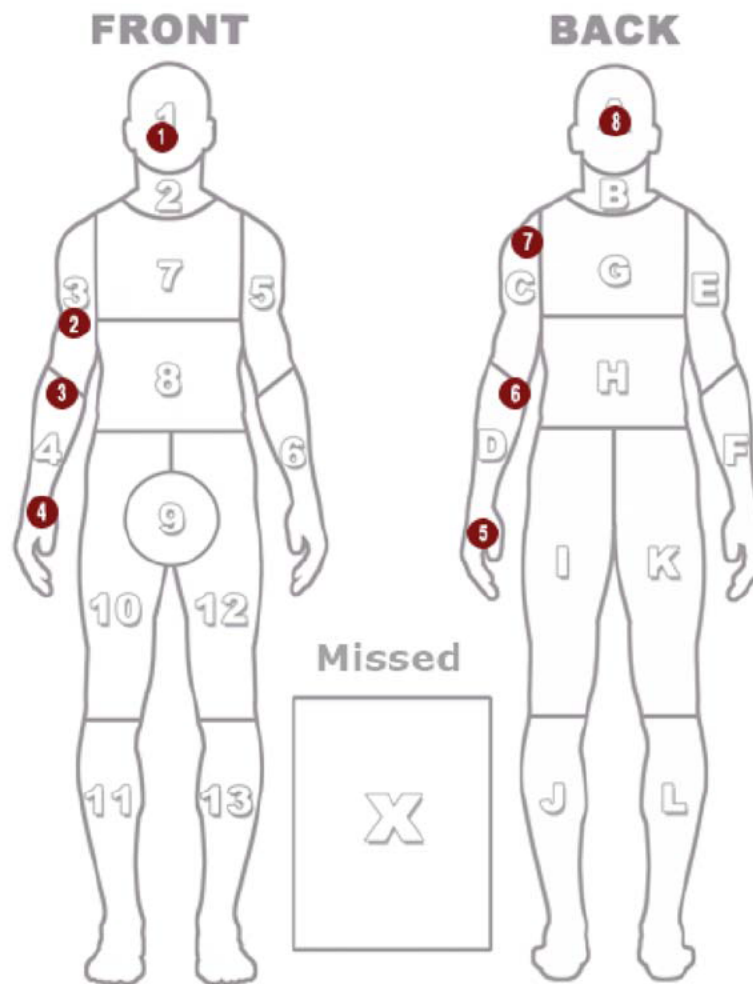
