SUMMARY:

On 02/17/2023 I assisted with a Trouble With Party investigations. Officers were called to the location multiple times for a disturbance caused by Her Xiong. Two separate people called in the disturbance. I spoke with both complainants over the phone. See officer LaBrec's initial report for additional information. This case is related to a domestic investigation reference Case #23-07339.

NARRATIVE:

INITIAL CALL FOR SERVICE:

On 2/19/2023 I was dispatched to the residence of 19.35(1)(am)2.a for a disturbance involving two people arguing. The incident was called in twice by Brett Sacia. Rachel Dehnart also called regarding this disturbance.

CONTACT WITH BRETT SACIA:

The first time I responded to this disturbance, I spoke with Brett over the phone. I verbally identified him. Brett stated he was in his girlfriend's apartment located at 19.35(1)(am)2.a. The apartment window was open. While inside the apartment, Brett heard a loud bang coming from outside. He stated that he did not believe the bang was loud enough to be a gun shot. Shortly after hearing the bang, Brett began to hear arguing coming from the alley 19.35(of the apartment building. He stated the male in this argument was predominant. He did hear the male loudly yelling "Fuck you." and "Fuck this." Brett was not able to see the individuals at this time. Brett did not have much other information to provide at this time.

CONTACT WITH RACHEL DEHNART:

The second time responding to this disturbance I spoke with Rachel Dehnart over the phone and verbally identified her. I spoke with Rachel after Her Xiong had been placed under arrest by Officer LaBrec for Disorderly Conduct.

Rachel stated she lives at 19.35(1)(am)2.a which is a few houses 19.35(of Her Xiong's address. She stated her unit is on the third floor. She had heard yelling coming from a few houses south of her. After hearing the yelling begin, she had looked out her window on the south side of her house. She stated she could see the male and female standing on the south side of the building. She stated they were on the back porch. She could hear the male angrily yelling statements such as "I will kill you" and "I will shoot you". She stated the female was speaking with the male trying to quiet him down.

Rachel also provided additional information in this statement regarding the domestic investigation under case #23-07339.

DISPOSITION:

Her Xiong was arrested by Officer LaBrec for Disorderly Conduct. See Officer LaBrec's report for additional information. Also reference case #23-07339 for additional information.
